

Telford and Wrekin Council Off-Street Parking Places - (Dark Lane, Telford Town Park) Order 2020

Notice is hereby given that Borough of Telford & Wrekin propose to make the Telford & Wrekin Council Off Street Parking Places - (Dark Lane, Telford Town Park) Order 2020 under the Road Traffic Regulation Act 1984, the effect of this Order is as follows:

1. The parking place subject to this Order ("the Parking Place") is an area of land located adjacent to Dark Lane, Telford Town Park, Telford.
2. The Telford and Wrekin Council (Off-Street Parking Places) Order 2014 – Dark Lane, Telford Town Park will cease to have effect in its entirety.
3. This Order shall introduce arrangements for use of the Parking Place, introduce Initial Charges, maximum permitted parking periods and introduce Penalty Charges for contravention of this Order.
4. From Monday to Saturday between 0900 hours and 1700 hours the Initial Charge in respect of a Vehicle or Trailer (not including a Public Service Vehicle) is as follows:
Where a Vehicle or Trailer is parked for
 - (i) Up to 30 minutes - £0.50
 - (ii) 30 minutes to 1 hour - £1.10
 - (iii) 1 hour to 2 hours - £1.60
 - (iv) 2 hours to 3 hours - £2.20
 - (v) More than 3 hours £3.00
5. On Sunday between 0900 hours and 1700 hours the Initial Charge in respect of a Vehicle or Trailer (not including a Public Service Vehicle) is as follows: Where a Vehicle or Trailer is parked for any length of time, £1.00
6. On any day of the week between 0900 hours and 1700 hours the Initial Charge in respect of Public Service Vehicles is as follows: Where the Public Service Vehicle is parked for any length of time, £10.00
7. the Driver of a Vehicle towing a Caravan into that Parking Place and the driver of a Motorhome shall not permit the Caravan or the Motorhome to wait in that Parking Place between the hours of 23:00 hours and 06:00 hours
8.
