Key Messages from the TWSP Executive

The TWSP Executive met on the 13th October and the key messages from this meeting to the Partnership were:

Establishment of Safeguarding Adults Board and Safeguarding Children Board

Following the review of the Safeguarding Partnership Arrangements the Executive welcomed the establishment of the Safeguarding Adults Board and Safeguarding Children Board. This enables the Partnership to have a clear focus on the specific safeguarding issues at a strategic level. This includes the re-engagement between the Safeguarding Children Board and school safeguarding boards to ensure that the voice of the child is prioritised within the partnership.

Sexual Abuse in Schools and Colleges

The Executive endorsed the decision of the Safeguarding Children's Board to to adopt sexual abuse in schools and colleges as a partnership priority and adopt a zero-tolerance policy and for all partners to make it clear sexual violence and sexual harassment is never acceptable. All partners have a role in challenging physical behaviour (potentially criminal in nature). Dismissing or tolerating such behaviours risks normalising them; this policy should include a position statement from partners on the current position of the partnership's response to Sexual abuse in education settings and its future aims and what work it will undertake. It was agreed that the TWSP will develop a work stream to help tackle, sexual harassment and sexual violence, including online and improve the level of oversight and understanding of the issues for children and young people in our local area.

Adult Exploitation Sub Group

The Executive commended the work of the Adult Exploitation Sub Group and the establishment of the Adult at Risk Project. It was confirmed that the Adult Exploitation Sub Group has completed its work programme and objectives and will no longer meet as a Sub Group of the Safeguarding Partnership and the delivery of the Adult at Risk Project will continue through the Community Safety Partnership arrangements.

Prevent and Channel Panel

The Executive received an update on Prevent and the work of Channel Panel. Telford and Wrekin's Channel Panel was formed in July 2015, and refreshed in spring 2020. Telford and Wrekin Counter Terrorism Local Profile (CTLP); is developed by the Police on an annual basis to understand any local identified risks. The Channel Panel own the CTLP and have an action plan to support and implement actions to tackle, explore and reduce risks of vulnerable children or adults being radicalised.

The process is underpinned by a robust partnership process that is centred around all local referrals being submitted into the Counter Terrorism Unit prevent hub (CTU) for registering onto the system and onward allocation to Counter Terrorism Case Officer (CTCO). Prevent training is being refreshed to ensure appropriate referrals are made to Channel, discussion currently being planned for the next Prevent board on how we can ensure all front line staff get the training, especially the Home Office online PREVENT training.

Multi Agency Response to Children and Young People in Emotional / Mental Health Crisis in Exceptional Circumstances

The TWSP Partnership Development Sub-Group has approved the multi-agency response to children and young people in emotional / mental health crisis in exceptional circumstances. The <u>Standard Operating Procedure</u> and the <u>Flow Chart</u> explain this process and how all partners can make referrals.

Reviews and Inquiries

The Executive noted the ongoing Independent Inquiry into Child Sexual Exploitation in Telford and the Ockenden Review of maternity services at Shrewsbury and Telford Hospital NHS Trust

White Ribbon 16 Days of Action Campaign

White Ribbon Day 2021 will be taking place on Thursday 25th November and Telford & Wrekin Council, as a White Ribbon accredited town, are running a 16 Days of Action campaign to raise awareness of male violence against women and encourage men to stand up against domestic abuse.

Last year, due to the Covid-19 pandemic, the campaign took place on the White Ribbon Telford & Wrekin Facebook page. This included advice and support, videos, inspirational quotes, lived experience speakers, and podcasts – including an interview with Rachel Williams, renowned domestic abuse activist and survivor.

This was a huge success with approx. 45,000 social media hits and a number of local women coming forward to seek help. This year, Telford & Wrekin Council have decided once again to use the White Ribbon Telford & Wrekin Facebook page to hold the 16 Days of Action campaign.
