

**Telford & Wrekin Council (Doseley Area, Telford) (Environmental Weight Limit 7.5 Tonnes – Accept for Access) Traffic Regulation Order 2023**

Borough of Telford and Wrekin (herein after referred to as “the Council”) in exercise of its powers under Sections 1(1), 2(1), 2(2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief of Police in accordance with Part III of Schedule 9 to the Act hereby propose to make the following Order;

1. This Order shall come into operation on ## day of #### 2023 and maybe cited as the Telford & Wrekin Council (Doseley Area, Telford) (Environmental Weight Limit 7.5 Tonnes – Accept for Access) Traffic Regulation Order 2023

2. In this Order, except where the context otherwise requires, the following expressions have the following meanings:

“Heavy Commercial Vehicle” shall have the same meaning as in Section 138 of the Act.

3. Save as provided in Article 4 of this Order no person shall, except upon the direction or with permission of a police constable in uniform or of a traffic warden, cause or permit any Heavy Commercial Vehicle exceeding 7.5 tonnes to proceed in the lengths of road specified in Column 1 of the Schedule One to the extent specified in Column 2 of that Schedule.

4. Nothing in Article 3 of this Order shall make it unlawful to use, cause or permit any Heavy Commercial Vehicle to proceed in the said lengths of road referred to therein if the vehicle is being used:

(a) For the conveyance of goods or merchandise to or from premises situated on or adjacent to the said roads and length;

(b) In connection with the carrying out on, or on premises situated on or adjacent to the said roads and lengths of road of any following operations, namely:

i) Building, industrial, excavation or demolition operations;

ii) The removal of any obstruction to traffic;

iii) The maintenance, improvement or reconstruction of the said roads and lengths of roads;

iv) The laying , erection, alteration or repair in, or in land adjacent to the said roads and lengths of roads, of any sewer or of any main, pipe or apparatus for the supply of gas, water, electricity or of any telecommunications apparatus as defined in paragraph 1(1) of the Telecommunications Code contained in Schedule 2 of the Telecommunications Act 1984;

(c) In an emergency for fire brigade, ambulance, or police purposes;

- (d) In the service of a local authority, or a water undertaker or sewerage undertaker, or the Environment Agency in pursuance of statutory powers or duties;
  - (e) To proceed to or from any premises situated in or adjacent to the said roads and length of roads at which the vehicle is to be, or has been, garaged in accordance with conditions imposed by the Traffic Commissioners, or at which the vehicle is to be serviced or repaired;
  - (f) For the purposes of agriculture on any land adjacent to the said roads and lengths of roads, or for or in connection with haulage of timber felled upon such land; or
  - (g) In connection with a circus fair or similar event holding of which on or in the vicinity of , the said road lengths of road has been authorised by the Council
5. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirement imposed by any regulations made or having effect as if made under the said Act of 1984 or by or under any other enactment.
