## Telford & Wrekin Council (Off Street Parking Places) (Addenbrooke House & Darby House Car Parks) Consolidation Order 2024

The Council gives notice that it has made the following Traffic Order that came in to force on 13<sup>th</sup> May 2024 The general effects of the order are to revoke the existing Telford & Wrekin Council Off Street Parking Places Order 2016 – Addenbrooke House, Darby House & Euston House Car Parks and consolidate into a new Order to update references to relevant definitions and current legislation.

## The Order:-

- Revokes and re-introduces arrangements for use of the Parking Places that are the subject of this Order.
- ii. Revokes and re-introduces parking Permits for use of the Parking Places that are the subject of this Order.
- iii. Revokes and re-introduces Excess Charges for contravention of this Order.

The Council gives notice that it has made the following Traffic Order which will come in to force on **01 Feb 2023** The general effects of the Order are to introduce waiting and stopping restrictions and various parking places on the roads listed:

- 1) Prohibition of Waiting and Loading At Any Time, on: Holyhead Road, Mill Bank, Dawley Road, Victoria Road
- 2) No Stopping on Keep Clear Entrance Markings Whitchurch Drive, Severn Drive
- Limited Waiting, Mon Fri 8am 6pm, Max Stay 1 hour, No Return within 1 hour Haybridge Road, North side, between Bridge Rd and Hollies Rd Market St, South side, between No 7 and No 23 King St, between Constitution Hill and Victoria Rd
- 4) Blue Badge Holders, At Any Time Market Sq, West side, outside No 7
- 5) Goods Vehicle Loading Bay, 8am 6pm, Max Stay 30mins, No Return within 1 hour Market St, North side, outside No 44.
