**TWC/2024/0800** – Fletcher Methodist Church, Court Street, Madeley – Demolition of fire damaged section of building

**TWC/2024/0818** – Rosehill House, Darby Road, Coalbrookdale – Repaint all external walls including stone quoins on rear elevation, refix slipped tiles, replace defective tiles, replace existing lead, repoint open joints, repaint roof lights, clear and repaint gutters, clear and treat vegetation on roof top, overhaul and repaint all windows including cast iron cills and lintels, clear and treat vegetation on stone cills and cornices above keystones, overhaul and repaint main door with triangular pediment, clear and treat vegetation on pediment and sandcast lead, remove, overhaul and repaint all rainwater goods and refit on new oak bobbins, install new cast iron rainwater down pipes where necessary, rake out and repoint chimneys and replace mortar flaunch where necessary

**TWC/2024/0819** – Dale House, 27 Darby Road, Coalbrookdale – Replace defective roof tiles with matching clay tiles, strip, re-line and re-lay all valleys, hips and ridges, repoint open parapet joints, repoint and deep pack replacement cast stone copings, renew rear flat lead roof, replace parapet gutter in lead, remove and treat all roof vegetation, remove, overhaul and repaint all rainwater goods and refit on new oak bobbins, where necessary replace any cracked or broken sections, repaint all windows, minor splice repairs to the outer linings, replace where necessary cill fronts, treat and repaint cast iron cills and lintels and repaint all doors

**TWC/2024/0820** – The Barn, Lees Farm, Coalport Road, Madeley – Change of use of annexe from residential to residential and holiday let

**TWC/2024/0821 & TWC/2024/0822** – 15 Burton Street, Dawley – Replacement of 2no first floor front windows (Full Planning Application & Listed Building Application)

**TWC/2024/0830 & TWC/2024/0831** – 7 Storchley Hall Court, South Barn, Storchley Road, Storchley – Replacement of single glazed exterior wooden front door and frame with a double glazed wooden door and frame. Removal of concrete plaster on lounge internal door and under stairway wall and replace with Lime plaster (Full Planning Application and Listed Building Application)

**TWC/2024/0843** – Coach House, Darby Road, Coalbrookdale – Replace defective roof slates with matching welsh slate, treat and redecorate all galvanised hips and ridges, remove, overhaul and repaint all rainwater goods and refit on new oak bobbins, where necessary replace cracked or broken sections with new cast iron, repaint all windows, treat and repaint cast iron cills and lintels and repaint all doors
